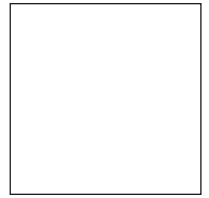

The undersigned, being eligible for membership in Wheatsfield Cooperative, a cooperative organized under Chapter 499 of the Iowa Code (the "Association") hereby applies for membership and subscribes for one (1) share of common stock, par value One Hundred Dollars (\$100) per share, for a purchase price of One Hundred Dollars (\$100).

1. The undersigned has had an opportunity to review a copy of the Articles of Incorporation and Bylaws of the Association available at www.wheatsfield.coop and agrees to be bound by the Articles of Incorporation and Bylaws of the Association, as amended from time to time.

Subject to the provisions of Section 1385(b) of the Internal Revenue Code, the undersigned hereby consents that the amounts of any distribution with respect to the undersigned's patronage which are made in written notices of allocation (as defined in Section 1388 of the Internal Revenue Code) will be taken into account by the undersigned at its stated dollar amount in the manner provided in Section 1385(a) of the Internal Revenue Code in the taxable year in which such written notices of allocation are received by the undersigned, all in accordance with the Articles of Incorporation and Bylaws of the Association.
